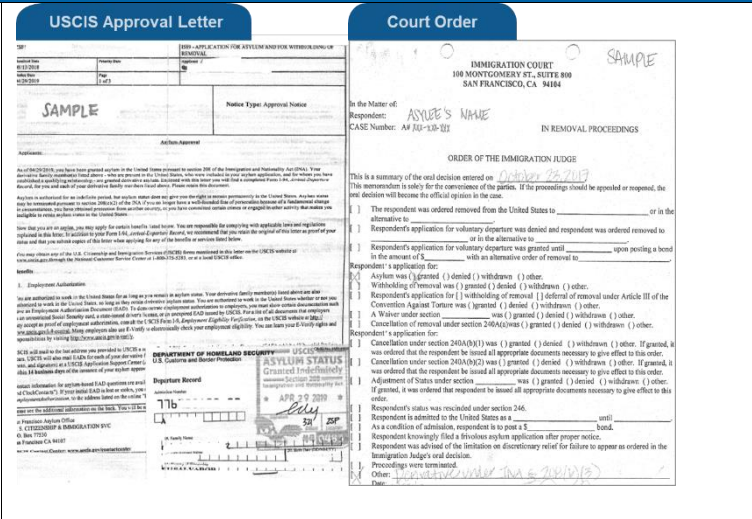

IMPORTANT DOCUMENTS

Asylum Approval Letter from United States Citizenship and Immigration Services (USCIS) or Court Order from Immigration Court

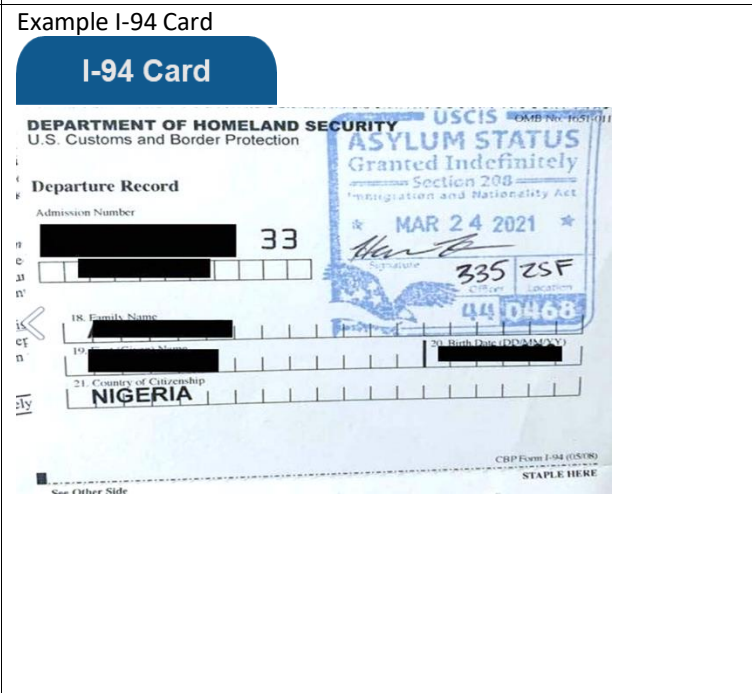
- Your asylum approval letter is a critical immigration document which serves as proof of your new status.
- The date granted is stamped within the approval letter.
- Your grant letter is necessary in order to obtain services and benefits as a new asylee.
- The date granted also begins an important timeline to apply for your spouse or minor-aged children under 21 years of age to join you here in the United States, if they live abroad.






I-94





Along with your asylum approval letter, your I-94 is a second critical immigration document. Your I-94 verifies your Immigration Status.


- All new asylees need both the asylum approval letter PLUS an I-94. See example of the document here.
- Until you have lawful permanent residency (green card) you will need to show your I-94 to new employers so they can verify your immigration status in the federal system.
- Asylees granted by USCIS Asylum Office automatically receive I-94 with grant letter.
- Asylees granted in an immigration court by a judge who do not receive an I-94 in the mail within 60 days post-grant should contact USCIS.
- Special note, asylees granted in an immigration court by a judge may already possess an I-94 from Customs and Border Patrol (CBP). However, CBP does NOT have your current immigration status as a new asylee in their system. You MUST obtain a new I-94 from United States Citizenship and Immigration



<p>Services (USCIS) which reflects your new status. Call the USCIS Contact Center.</p> <ul style="list-style-type: none"> If you need to fix an error on your I-94 issued to you as a new asylee, you must call the USCIS Contact Center. 	<p>USCIS Contact Center Open 8am-8pm M-F Eastern Time 800-375-5283</p>
<p>Employment Authorization Document (EAD)</p> <ul style="list-style-type: none"> If you are granted asylum, you are immediately authorized to work. Some asylees choose to obtain an EAD for convenience or for federal identification purposes, but an EAD is not necessary to work if you are an asylee. Asylees only apply or renew an EAD if a federal form of photo identification is wanted or needed. If you currently have an EAD that will expire soon and still need a federal form of identification, the validity of the EAD has been extended 540 days. However, to receive the 540-day extension, you MUST file to renew your EAD by mail or online BEFORE it expires. <p>Social Security Number (SSN)</p> <ul style="list-style-type: none"> Unique lifetime identifier necessary for employment, taxation, and retirement benefits in U.S. Guard your number against theft! <p>First Time Applicants:</p> <ul style="list-style-type: none"> Visit your local field office. Bring asylum grant letter to apply for all individuals granted asylum. Adults need a form of valid form of photo ID such as unexpired passport or Employment Authorization Document. Social Security card arrives in approximately 30 days. <p>How to Change from a Restricted Social Security Card to an Unrestricted Social Security Card</p> <p>For those with a restricted card, the card will be imprinted with the words “Valid for Work Only with DHS Authorization.” See the top card for an example of a card that is Restricted and Temporary.</p> <p>Return as soon as possible to Social Security Administration with your restricted card to update immigration status in the federal system.</p> <ul style="list-style-type: none"> Visit your local field office. <p>Standard California Identification and Driver's License (Federal Non-Compliant)</p> <ul style="list-style-type: none"> • May not be used as a form of federally compliant identity to enter federal facilities or board domestic airline flights within the U.S. beginning May 7, 2025. • Standard "Non Federal Compliant ID has a picture of a man in the upper right hand corner and is stamped with the words "Federal Limits Apply" • To apply, bring valid form of photo ID, proof of social security number, 2 proofs of your current address, and fees. • Individuals may request a cost reduction form if enrolled in any public benefit program from Human/Social services and bring it to the DMV. • Beware of "look alike" DMV websites. 	<p>California Department of Motor Vehicles (DMV) https://www.dmv.ca.gov</p> 
<p>Real ID and Driver's License (Federal Compliant)</p> <ul style="list-style-type: none"> • May be used for entry to federal facilities or to board domestic airline flights within the U.S. In the absence of another form of federal identity document such as valid passport or valid Employment Authorization Document, a Real ID will be required by May 7, 2025 for federal compliance purposes. • Real ID has a picture of a bear and star in the upper right corner. <p>HOW TO APPLY FOR PUBLIC BENEFIT PROGRAMS</p>	
<p>Public Benefit Programs Must meet income eligibility for CalFresh (food), Medi-Cal (healthcare coverage), and CalWORKs/Refugee Cash Assistance (employment/cash) programs. even if residing in the same household as other family members/applicants for CalWORKS cash aid. Include a self-declaration of how much the applicant will contribute to overall household rent/costs and list the names of family members who shop and cook food together in the household on the RCA application.

*Discuss with the county eligibility worker any documents that you do not have or are in the process of obtaining. If you have a good reason/cause, your benefits may be activated while waiting for supporting documents to arrive.

HOW TO CHANGE FROM EMERGENCY SCOPE TO FULL SCOPE MEDI-CAL COVERAGE

If you need to change Medi-Cal from emergency scope to full scope Medi-Cal coverage, you must visit your County Human or Social Services Agency to update your new immigration status.

Note, if you move to a new county, you must request a transfer of your Medi-Cal to the new county by visiting the Human/Social Services in the new county where you live.

Bring:

- Medi-Cal cards for all new asylees in house
- Asylum Grant Letter
- I-94s
- Unrestricted social security cards
- Valid photo ID
- 2 proofs of your current address
- Most recent bank statements or declaration of lack of bank account and sources of income and how much earned.
- Within 45 days, you should receive a Notice of Action from the county which details whether you have been approved for full scope Medi-Cal.
- If approved, simply continue to use your old card. The card remains valid. The county and state system will retain your same Medi-Cal identification number BUT the systems will now be updated to reflect your new status.

*Discuss with the county any documents that you do not have or are in process.

For quickest service, visit your local County Human or Social Services Agency office to make the change in person. Do NOT make a new Medi-Cal application.

Individuals with existing online accounts may be able to use the message a worker feature to inform the county of new immigration status and upload all the supporting documents listed here to request a change from emergency to full scope Medi-Cal.

Full scope Medi-Cal provides greater access to services than emergency or restricted scope Medi-Cal. Full scope Medi-Cal provides ongoing access to primary care for all routine and urgent care, transport to appointments at no-cost, dental and vision services, and interpretation services.

HOW TO OBTAIN HEALTH INSURANCE IF YOUR INCOME IS TOO HIGH TO QUALIFY FOR MEDI-CAL

Insurance through Employment

To obtain insurance through work, provide your employer with updated immigration status as an asylee. Individuals may have to wait for open enrollment period (usually late fall for coverage beginning January 1st).

Covered California

- If your employer does not offer insurance or you must wait to enroll, individuals have **60 days** of a qualifying life event (which includes loss of Medi-Cal or change of immigration status to a new asylee) to buy health insurance through the state health insurance exchange Covered California.
- If you do not buy insurance, you will face a state tax penalty at the end of the year.



<p>Refugee Travel Document</p> <p>To travel internationally, USCIS issues Refugee Travel Documents to people with refugee or asylum status and to lawful permanent residents who obtained their Green Cards based on their refugee or asylee status.</p> <ul style="list-style-type: none"> You must have a Refugee Travel Document to return to the U.S. if you have refugee or asylee status. If you do not obtain a Refugee Travel Document before you leave the U.S., you may be unable to re-enter or you may be placed in removal proceedings before a judge. You must check with the consulate of the country you intend to visit to inquire whether a Refugee Travel Document will be accepted for entry. ADJUSTMENT OF STATUS TO LAWFUL PERMANENT RESIDENT/GREEN CARD

<p>There are two components to apply for adjustment of status to Lawful Permanent Resident.</p> <p>Form I-693 <i>Report of Immigration Medical Examination and Vaccination Record</i> AND</p> <p>Form I-485 <i>Application to Register Permanent Residence or Adjust Status</i></p> <ul style="list-style-type: none"> You are currently not required to submit both forms together.
