Card are available in print form in Spanish and English, you can download PDFs and print your own in other languages.

Q&A and info to share with community members:

Sanctuary City status: local enforcement will not cooperate with federal enforcement.

- Federal enforcement would be challenged in SF.
- Asylee applicant can be arrested and held.
- Instant deportation
- Pending refugees, asylee, etc. can be detained, but not deported and have right to court hearing. Affirmative cases then become defensive cases.
- Immigration cases can take up to 5 years. So not necessary to take voluntary departure. Don't sign!
- Immediate Deportation only for those already deported, order of deportation, have no fear of returning to home country.
- Federal Immigration laws take many years to change.

Department of Rehabilitation - Evan Xu, Senior Vocational Rehabilitation Counselor– <u>Wxxu@dor.ca.gov</u>. Employment services to help immigrants with disabilities to get work. To be eligible you must, authorized to work, issues preventing from obtaining work such as mental and/or physical barriers, and be motivated to join the workforce. Services include:

Assessments and support including trainings to re-join workforce.

Individualized Plan for Employment and Training

Career education/training, Job search/interview skills, Job coaching, on-the-job training.

Placement in various fields/janitorial, security, HR, medical assistant.

1-2 years follow-up with case manager.

SF / Marin Food Bank CalFresh Outreach Program - Francesca Costa – <u>fcosta@sfmfoodbank.org</u> – Provides assistance to low income households. CalFresh Hotline -

CalFresh alleviates financial stress, increases access to healthy food but CalFresh is an underutilized program! Only about 50% of eligible SF/Marin are receiving benefits. CalFresh is NOT a public charge benefit.

SF-Marin Food Bank provides:

- Direct Services: outreach, prescreening, application assistance, available for follow-up, advocacy, questions. Collaborate with the county social services and can follow up on cases.
- Extensive trainings for intake, case managers. One day training at food bank.
- Assistance trouble shooting and advocacy, case information.
- Agencies can send referral on behalf of client.
- \$50 per approved application.
