## **Legislative Update:**

ACA/Covered CA – SF update –Immigrant, Refugee, Asylee, T & U visas applications & challenges Humberto Trinidad -MediCal Specialist

- Certain lawfully present immigrants qualify for plans under the Affordable Care Act.
- One application determines Medi-Cal or Covered California (ACA). Be sure tax info is complete and signatures are included. Auto renewal selection option on page 17. Enter "refugee/asylee" in Document Type
- Be sure to complete forms to avoid processing delays.
- RMA recipients will receive letters requesting more info when their case will be re-evaluated post 8-months.
- In SF, those on Refugee Medical Assistance (RMA) will automatically continue on Medi-Cal after the 8-month RMA expiration until the state implements new guidelines.
- Remind your clients to respond to any Medi-Cal requests!
- Other counties have not recognized the need to override options after RMA expiration.
