DACA: The judicial hold on the executive action programs for deferred action. A judge issued an injunction and the program is indefinitely put on hold. There will be a hearing in the 5th Circuit soon if the program is allowed to move forward. There is a significant decrease in participation since the injunction. *CA Driver's Licenses (AB60):* ICE has access to DMV database but it's unclear how it's used. If individual is in "immigration fugitive" status then it is a risk to apply for a CDL and some risk to fly since TSA is trained by CBP. Undocumented status is less at risk. Application for CDL can only be for driving privileges, not to be used for accessing other services.

Government says they only prioritize "order of removal" as of January 2014.

Health Care: There is an ACA/health insurance mandate. For those not eligible for ACA they must file for an exemption to avoid the fee based on not being eligible. No real case updates at this time. Please share what you learn.
