# Partner Agency Presentation:

Syrian Resettlement Project- Sysvanh Kabkeo- CDSS/Refugee Programs Bureau Chief.

- For the federal fiscal year, 2016-2017, 10,000 Syrian refugees are expected to immigrate to the United States.
- Areas that are or are expected to be impacted by Syrian refugees include San Diego and Sacramento.
- Due to the closure of camps, a high volume of Burmese and Thai people are expected to immigrate to the United States in the near future. Immigrants from Middle Eastern countries are also expected to arrive in large volumes.
- The California Endowment has awarded a grant of \$360,000 for the federal fiscal year 2016-2017, which will be utilized to assist 22 resettlement agencies for refugees.
  - o It is the agency's desire to distribute the grant as soon as possible.
  - \$5,000 will be given to Resettlement Agencies with the requirement that all participating resettlement agencies meet, in person, twice a year.
  - Resettlement agencies can apply for this grant. Grants will be awarded based on how well the resettlement agencies fit Syrian refugees' special needs.

The office of Civic Engagement & Immigrant Affairs is a new city government office that supports policies and programs known to develop inclusiveness and easy access to benefits and resources for recent immigrants. This is accomplished by collaborating with other organizations and agencies, and providing grants for certain programs.

## • Local Policy:

- Language Access Ordinance: Requires all city departments to communicate with the public in their native tongue. All documents should be automatically translated to Spanish, Cantonese, and Tagalog. In addition, other languages should be translated upon recipient's request. The office of Civic Engagement & Immigrant Affairs requires all city departments to write an Annual Compliance Report that details how many bilingual staff were hired, frequency of translation services, etc.,.
- o Sanctuary City Ordinance
- Municipal Identification cards are intended to facilitate access to services for undocumented immigrants. There is a \$15.00 fee. Homeless individuals can obtain a fee waiver by presenting a letter from a local shelter, indicating their housing situation.

#### • Programs:

 Community Ambassadors Program provides multilingual education and safety forms and tools.

- Direct service program, community ambassadors program. Provides multilingual education, and safety.
- The Day Laborers Program's goal is to prevent wage theft and to regulate and ensure the safety of the workers. While open to all laborers, the program is focused on preventing unfair work practices in order to protect undocumented immigrants who work in construction, gardening, and painting.
- La Collectiva/ The Women's Collective is a program developed to educate and protect undocumented immigrant women from unfair work practices; particularly those who work in housekeeping, daycares, and restaurants.

### Funded Programs:

- SF Pathways to Citizenship Initiative offers free legal services and workshops regarding how to file different immigration forms (DACA & Naturalization) for immigrants who live, work or study in San Francisco.
- The Office of Civic Engagement and Immigration Affairs funds 12 nonprofit Language Access
   Programs that serve to educate and empower the public on their rights pertaining the Language
   Access Ordinance
- Currently the Office of Civic Engagement and Immigration Affairs are looking for volunteers to assist in various tasks. Bilingual volunteers are highly desired; however monolingual speakers are also encouraged to volunteer.

# Refugee Awareness Month in review- Efrain Sandoval, Case Manager & Employment Specialist

- 250 people attended the Refugee Awareness Month, where there were raffles, food, talent show, and music.
